2025 Young Eagles® Raffle Rules

EAA Aviation Foundation, Inc. ("Foundation") is a nonstock, non-profit corporation incorporated under the laws of the State of Wisconsin, located at 3000 Poberezny Road, Oshkosh, Wisconsin 54902, with a primary focus on supporting Experimental Aircraft Association, Inc. ("EAA"), which provides programs and activities to educate and engage aviation enthusiasts. The 2025 Young Eagles Raffle ("Raffle") is conducted by Foundation for the purpose of generating funds to support the youth education outreach activities of EAA, including EAA's Young Eagles program.

- 1. Eligibility. The Raffle is open to any eligible person residing in, or visiting, Wisconsin during the Raffle Period unless prohibited by law or the rules set forth herein ("Rules"). Any individual who is an employee, officer, director or trustee of EAA Aviation Foundation, Inc., or of EAA, International Aerobatic Club, Inc., EAA Vintage Aircraft Association, Inc., EAA Warbirds of America, Inc., or of any of their respective advertising or promotional agencies, or anyone who is involved in the development or execution of the Raffle, or who is an immediate family member or household member of any such persons, is ineligible to enter the Raffle or to win the Raffle Prize. For the purposes of these Rules, an "immediate family member" means a spouse, parent, legal guardian, child (natural or adopted) or legal ward, of the ineligible person. Each entrant, by purchasing a single entry ticket for the Raffle ("Ticket"), agrees to abide by these Rules, as well as with all applicable local, state and federal laws and regulations, and further agrees to release Foundation, and, for the purpose of this Raffle, EAA, and their respective directors, officers, divisions, associates, agents, employees, and volunteers, from any and all liability with respect to all aspects of the Raffle, including, but not limited to, the drawing and winner selection process. Pursuant to Wisconsin law, any entrant who is not eighteen (18) years of age or older must have the written and notarized permission of his or her parent or legal guardian to take title to the Prize.
- 2. <u>Raffle Period</u>. The Raffle will begin on March 31, 2025 at 10:00 a.m. CT and will end on Sunday, July 27, 2025 at 12:00 p.m. CT ("Raffle Period").
- 3. <u>Ticket Purchases.</u> The purchase price for a Ticket is One Hundred Dollars (\$100.00) per Ticket (U.S. Funds only) and is not tax deductible. Any entrant may purchase more than one Ticket. Participants can enter the Raffle by purchasing one or more Tickets: (a) at the EAA Aviation Museum™ between 10:00 AM and 5:00 PM daily (excluding holidays or when the Museum is closed) throughout the Raffle Period; (b) throughout Wisconsin at certain events during the Raffle Period; and (c) on the EAA® AirVenture® Oshkosh™ grounds during normal operating hours starting on Monday, July 21, 2025 with all sales concluding on Sunday, July 27, 2025 at 12:00 p.m. CT.

Ticket payment can be made by Visa, MasterCard, Discover, American Express, debit card, cash, check, or money order. If a bank, for any reason, dishonors an entrant's payment, the Ticket(s) purchased with such payment will be declared invalid unless full and satisfactory payment is made prior to the conclusion of the Raffle Period. Any dishonored, refused or rejected credit card, check or money order payment will be considered an invalid entry and, while Foundation will endeavor to notify the entrant by mail, email, or telephone as to the invalid entry, Foundation shall have no liability if it is unable to notify any such entrant after using reasonable efforts to do so.

Irrespective of the time and place of Ticket purchase, to be eligible for the drawing, a completed Ticket entry must be in possession of Foundation at 3000 Poberezny Road, Oshkosh, Wisconsin, by 12:00 p.m. CT on Sunday, July 27, 2025, or before one thousand five hundred (1,500) valid Tickets are sold, whichever comes first, at which time the sale of Tickets will be closed. All Ticket entries will be handled and recorded by Foundation on a first come, first served basis. Any Ticket entries and payments (including payments previously dishonored) received after conclusion of the Raffle Period will be returned to the entrant.

4. <u>Prize.</u> The winner of the raffle will receive a 2024 Ford Bronco sport utility vehicle complete with a Big Bend trim package (ARV \$50,513.50) ("Prize"). The winner understands that the Prize will have accumulated promotional miles. The winner must claim the Prize, and take title to the Prize by September 30, 2025 at 4:00 p.m. CT. The winner is solely responsible for any and all costs associated with title, registration, licensing, delivery, and other applicable fees

(including any taxes and fees imposed by a non-U.S. resident winner's country of residence and/or domicile) associated with the Prize, as well as for all local, state, and federal taxes, including without limitation all luxury, special, and income taxes that may be applicable. The winner will be required to provide Foundation with a valid social security number (or equivalent for a non-U.S. winner) and must complete all IRS and similar forms requested by Foundation prior to delivery of the Prize. Failure to do so within thirty (30) days of Foundation's request shall result in forfeiture of the Prize and award of the Prize to another entrant in accordance with these Rules. Foundation will make good faith efforts to award the Prize.

- 5. <u>Winning Chances.</u> A maximum of One Thousand Five Hundred (1,500) Tickets will be sold. Each Ticket represents one chance to win the Prize. An eligible person may enter as many times as desired. Chances of winning the Prize depends on the total number of eligible Tickets sold.
- 6. <u>Drawing.</u> The winner of the Prize will be determined by a random drawing of all the eligible Tickets received by Foundation by 12:00 p.m. CT on Sunday, July 27, 2025. The drawing will be held at 2:30 p.m. CT on Sunday, July 27, 2025 at the AirVenture Welcome Center, EAA® AirVenture® Oshkosh™, 3000 Poberezny Road, Oshkosh, Wisconsin 54902. The entrant need not be present to win the Prize.

The random drawing for the Prize will be conducted in a single drawing session. During the drawing session, Foundation will draw successive provisional winning entries to be used if a potential Prize winner, for any reason, does not claim or is not awarded the Prize for which his or her entry was selected, or is otherwise determined to be ineligible for the Raffle. The first selected entry will be awarded the Prize, subject to confirmation of eligibility, Prize acceptance and entrant's compliance with the Rules and all applicable laws. In the event the Prize is not awarded to such entrant, the process will be repeated with the next selected successive drawn entry, as necessary to award the Prize.

Foundation's portion of all Tickets will be held for one (1) year at the EAA Aviation Center. Ticket holders who wish to observe the drawing may obtain free admission to the AirVenture grounds one (1) hour prior to the drawing, starting at 1:30 p.m. Ticket holder must show proof of Ticket purchase to obtain said free admission. Any questions or problems gaining admission should be directed to Foundation at 1-888-500-5600.

- 7. Winner. The winner will be notified in person, if present, otherwise the winner will be notified by telephone, e-mail, or by U.S. Postal Service mail using the information provided by entrant on the Ticket. The winner's name will be made available, without limitation, to all media and at the offices of Foundation and EAA and listed on www.EAA.org/YERaffle, no later than September 30, 2025. To receive the winner's name by mail, send a request and a stamped, self-addressed envelope to EAA Aviation Foundation, Inc., P.O. Box 3086, Oshkosh, WI 54903-3086. The Prize winner agrees to allow Foundation and/or EAA to use his or her photo, name, and likeness, and any statements made regarding the Prize, for advertising or publicity purposes, without compensation or prior approval. Winner may be required to complete and return an affidavit of eligibility and liability release. Upon failure to do so, if requested, or upon failure to comply with these Rules and/or to make arrangements to claim the Prize within fourteen (14) days of notification, the Prize will be deemed to have been forfeited and will be awarded to the next Ticket that was drawn.
- 8. Awarding of Prize. More than one (1) name may be listed on a registration form, but the first name listed on the Ticket shall be deemed to be the winner. A social security number (or equivalent for a non-U.S. winner) must be provided, and it must be that of the winner. Delivery of Prize shall be made solely to the winner. It is the sole responsibility of the winner in a multiple party entry to allocate any such Prize among the participants in such multiple party entry. The winner is solely responsible for all applicable taxes, licenses, registration fees imposed by any applicable governmental authority, and any transportation or shipping fees. Given the value of the Prize is \$5,000.00 or more, Foundation is required to collect applicable U.S. Federal income taxes, based on the Approximate Retail Value ("ARV") of the Prize, net of ticket cost, from the U.S. winner of the Prize, before the winner may take possession of the Prize. Foundation will report to the IRS any awarded Prize valued at more than \$600.00.
